MORRY BREEN COMPLEX ACCESS POLICY

Pedestrian Access

Entry to the grounds is prohibited whilst the gates for pedestrians are locked. Parents should ensure children do not enter the grounds by climbing over the perimeter fence or through holes or gaps in the perimeter fence.

Wyong Rugby League Club Group will not be liable for any loss or damage suffered by persons entering the grounds without permission.

Wyong Rugby League Club Group will not be liable for any loss or damage suffered by pedestrians as a result of motor vehicle impact in the car parking areas of the complex.

Vehicular Access

The gates in the perimeter fence facilitating vehicle entry to the grounds must remain clear at all times for Ambulance and other emergency service vehicles, and for maintenance vehicles, plant and equipment.

Vehicles are not permitted to enter the grounds or remain inside the perimeter fence without the express permission of Wyong Rugby League Club Group. Enquiries in this regard ought be directed to the Club via email admin@wyongleagues.com.au or telephone (02) 43 922 799.

Alcohol

Alcohol is strictly prohibited from the grounds and contiguous car parking areas during junior sporting events and junior training. During senior sporting events the grounds are part of the licensed premises and alcohol may not be brought inside the perimeter fence, removed from inside the fenced area, or consumed in the contiguous car parking areas.

Illicit Drugs

Illicit drugs are strictly prohibited from the grounds and car parking areas, and without exception Police will be notified in the event any person is observed in possession or otherwise using such drugs.

Animals

Animals (with the exception of police dogs and corrective services dogs being used on official duties, and assistance animals as defined in S.9 Disability Discrimination Act 1992 (Cth)) are strictly prohibited from entering the grounds.

Glass

Glass bottles and glass containers must not be brought inside the perimeter fence at any time.

Bicycles, Scooters, Skateboards, Roller skates etc

The riding of bicycles, scooters and skateboards, and the use of roller skates and the like, is strictly prohibited inside the perimeter fence and contiguous car parking areas.

Smoking

Smoking cigarettes and other tobacco products is strictly prohibited inside the perimeter fence and within 20m of any access gate.

Car Parking Areas

There is limited car parking space available, and all care should be taken in the unmarked areas of the car parks to maximise the use thereof.

Persons parking or driving vehicles within the Morry Breen Complex do so at their own risk. Wyong Rugby League Club Group will not be liable for any loss or damage to motor vehicles or their contents associated with or resulting from such activities. Further, Wyong Rugby League Club Group will not be liable for any loss or damages suffered by persons travelling in or occupying such vehicles.

The car parking area immediately south of the main public entrance to Wyong Leagues Club will be quarantined for use by members of the licensed Club at times when the grounds are subject to heavy patronage.

Use of the car parking area immediately north of Wyong Leagues Club is prohibited to all except employees of Wyong Rugby League Club Group and its authorised suppliers.

Vehicle drivers need to be particularly conscious of the numbers and ages of children in and about the car parking areas during special events and on match and training days, and navigate these areas with appropriate care and attention.
